Greetings from Spices Board!

As you aware, India is the leading producer, consumer and exporter of spices in the world. During 2023-24, India exported 15,39,692 MT of spices and spices products valued at Rs.36, 958.81 Cr (4,464.17 million USD). The major contributors in the spices export basket are Chilli, Cumin, Spice oil & Oleoresins, Mint products, Turmeric, Curry powder, Cardamom(small) and Pepper, of which the Chilli and Chilli products contributes to over 39% in terms of volume and 33.80% in terms of value of the total export earning of spices.

Karnataka being one of the major producers of chilli in the country holds a significant position in the spice sector of India. Key spices cultivated in the state include GI tagged Byadagi chilli and other chilli varieties in Dharwad, Haveri, Gadag, Bagalkot, Bellary, Raichur, and Gulbarga; turmeric in Bagalkot, Belagavi, Bidar, Gulbarga, Chamrajnagar, and Mysore; garlic in Bijapur, Bagalkot, Bellary, and Gadag; and coriander in Gadag, Haveri, Bijapur, Bagalkot, and Belagavi.

Spices Board (Ministry of commerce & Industry, Govt. of India) the flagship organization for the development and worldwide promotion of Indian Spices has been spearheading activities for promotion and facilitation of spices trade by strengthening linkages at various levels of the Spice Industry.
